IMPORTANT INFORMATION

- 1. Candidates may not nominate themselves.
- 2. Candidates for Collective President positions must obtain 10 valid nominations.
- 3. Candidates must meet the following qualifications to be nominated to lead a collective:
 - a. Gender Empowerment Collective self-identify as a woman, trans person, or gender queer individual.
 - Indigenous Collective self-identify as a member of the indigneous community
 - c. International Students' Collective be a registered international student at BU
 - d. LGBTTQ+ Collective self-identify as a member of the LGBTTQ+ community
 - e. Racialized Collective self-identify as a racialized person.
- 4. Collective President candidates must be nominated by students that self-identify as members of their constituency.
 - a. for example, a candidate for the President of the Gender Empowerment Collective must be nominated by BU students that self-identify as women, trans people or gender queer individuals.
- 5. All election forms must be emailed to the Returning Officer or handed in at the BUSU office during office hours for approval.
- 6. Any questions or concerns regarding the elections process must be brought to the Returning Officer only and not to the regular BUSU staff. You may reach the RO through email: election@busu.ca
- 7. By signing this package you consent to The Registrar's Office confirming that you are a BU student in good standing (minimum 2.0 GPA and no academic or non-academic notations on record.)
