TERMS & CONDITIONS

The Assiniboine Community College Students' Association (hereafter, ACCSA) and Brandon University Students' Union (hereafter, BUSU), representatives of the Paw Pass Program, hereby agree to the following terms & conditions:

1. ACCSA and BUSU shall provide to the discount provider each of the following in advance of the start of the discount period:
 - a. Examples of acceptable Paw Pass discount cards.
 - b. Window decals and other promotional materials for display on your premises.
2. The discount provider shall be listed in all relevant Paw Pass publication, including but not limited to the ACCSA and BUSU websites, posters displayed at ACC and BU campuses, and in the Paw Pass brochure.

The Business hereby applies to participate in the Paw Pass discount program, based on the terms & conditions set out in this agreement in respect of the businesses listed. The Business agrees to the following terms & conditions:

1. The Business agrees to provide the ACCSA and BUSU with their business logos in order to advertise directly on the Paw Pass Brochure, posters, and other promotional material.
2. The Business gives their express permission for ACCSA and BUSU to mention them in any advertising or promotional literature, brochures and directories, which may include details such as business name, merchandise and/or services sold, and concessions available to Paw Pass cardholders.
3. The Business understands that they may require the cardholder to present the card before the sale is entered, and may deny the cardholder in the event that it is not.
4. The Business agrees to accept all valid Paw Pass cards.
5. The Business agrees to exhibit Paw Pass decals in a prominent location on their premises.
6. The Business agrees to provide the listed discount for the entire term of this Partnership Agreement.

If any of the above terms and conditions are not followed by ACCSA, BUSU, and the Business, the parties reserve the right to determine this agreement null and void with a minimum of thirty (30) days notice to all other parties.

AGREEMENT & AUTHORIZATION

This Partnership Agreement shall come into effect immediately after the signing date, and ending August 31, 2021, with opportunity for extension in the future.
